"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

ALL that certain lot of land with all improvements thereon lying in the State of South Carolina, County of Greenville, in the northwestern corner of the intersection of McAdoo Avenue and Monticello Avenue, shown as Lot #73 on Plat of Glen Grove Park recorded in the RMC Office for Greenville County in Plat Book F, at page 233, and being further described as follows:

BEGINNING at an iron pin on the western side of McAdoo Avenue at the corner of Lots #73 and #74, running thence along the line of Lot #74, N74-12W 144 feet to iron pin on eastern side of proposed alley; thence along eastern side of said proposed alley S15-48W 50 feet to iron pin at rear corner of Lot #72; thence along line of Lot #72, S74-12E 10O.4 feet to iron pin on northwestern side of Monticello Avenue; thence along Monticello Avenue N76-56E 49.8 feet to iron pin at intersection of McAdoo Avenue and Monticello Avenue; thence along western side of McAdoo Avenue N15-48E 27 feet to point of beginning.
