TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, Milton T. Monroe

with interest thereon from maturity at the rate of ten per centum per annum, to be paid: on demand.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeastern corner of the intersection of Welcome and McClain Avenues and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the southeastern corner of the intersection of Welcome and McClain Avenues and running thence along the south side of Welcome Avenue, N.59-00 E. 115 feet to an iron pin; thence S.32-24 E. 191.0 feet to an iron pin; thence S.66-29 W. 169.4 feet to an iron pin; thence along the eastern side of McClain Avenue, N.15-00 W. 175 feet to the point of beginning.
