with interest thereon from date

at the rate of 14.15 per cent, per annum to be computed and paid monthly

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said Southern Bank and Trust Company, Williamston, S. C., its successors and assigns:

All that certain piece, parcel or lot of land with improvements thereon lying and situate in the Piedmont Manufacturing Company Village, in or near the town of Piedmont, Greenville County, South Carolina, and being more particularly described as lot no. 65, section 4, as shown on a plat entitled (Property of Piedmont Manufacturing Company, Greenville County) made by Dalton & Neves, February, 1950, Sections 3 and 4 of said plat are recorded in Plat Book Y at Pages 2-5, inclusive and Pages 6-9, inclusive, respectively.
