"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot 14 on a Plat of WINDSOR OAKS Subdivision, Sections I and II, prepared by Kermit T. Gould, Surveyor, recorded in the RMC Office for Greenville County in Plat Book 7-C, at Page 8, and having, according to said Plat, such metes and bounds as appear thereon.

This property is conveyed subject to easements, conditions, covenants restrictions and rights of way which are a matter of record and actually existing on the ground effecting the subject property.
