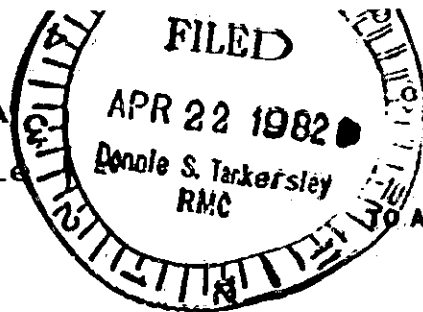

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, I, the said Maudine Sullivan, also known as Maudine Sullivan Carter (hereinafter referred to as Mortgagor) is well and truly indebted unto Pickensville Finance Company

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Two Thousand, Three Hundred Fifty-two and 00/100- - Dollars (\$2,352.00) due and payable

in 24 successive monthly payments of (\$98.00) Ninety-eight and 00/100's Dollars beginning May 25, 1982 and due each and every 25th. thereafter until the entire amount is paid in full.

with interest thereon from ~~date~~ ^{maturity} at the rate of eighteen per centum per annum, to be paid: semi-annually

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that piece, parcel or lot of land in the Town of Simpsonville, County of Greenville, State of South Carolina, being more fully described as follows:

BEGINNING at an iron pin on the northwestern corner of said lot running thence S. 12-30 E. 2.64 chains to an iron pin; thence N. 76-45 E. 1.03 chain to an iron pin; thence N. 10-15 W. 2.66 chains to an iron pin; thence S. 76-45W. 1.14 chains to the beginning corner."

This is the same property as conveyed to Maudine Sullivan by deed recorded in Deed Book 846, at page 360 and recorded June 13, 1968.

The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
