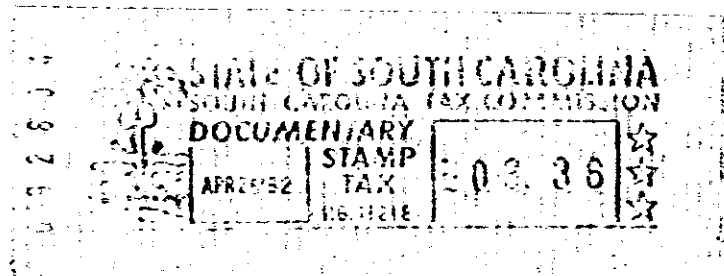
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the Dunean Mills Village, and being more particularly described as Lot No. 84, Section 4, as shown on a plat entitled "Subdivision for Dunean Mills, Greenville, SC", made by Pickell & Pickell, Engineers, Greenville, SC, on June 7, 1948, revised June 15, 1948 and August 7, 1948, and recorded in the RMC Office for Greenville County in Plat Book S at pages 173-177, inclusive. According to said plat the within described lot is also known as No. 62 Hutchens Street and fronts thereon 48 feet.

DERIVATION: This being the same property conveyed to the Mortgagors herein by virtue of a deed from J. P. Stevens & Co., Inc. to Mildred I. Stowe and Sarah L. Stowe recorded in the R.M.C. Office for Greenville County in Deed Book 377 at Page 429 on March 1, 1949; and by virtue of a deed conveying her undivided one-half interest from Sarah L. Stowe to Alene S. Edwards recorded in the R.M.C. Office for Greenville County in Deed Book 580 at Page 496 on July 22, 1957.
