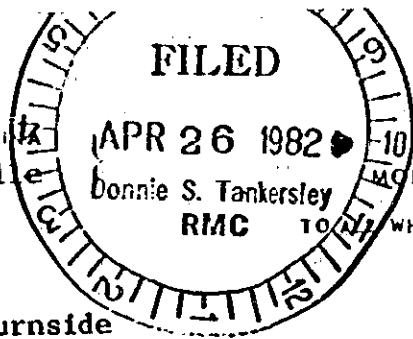

Thirty Six (36) Monthly Installments of One Hundred ten dollars and no/100s (110.00) with the first installment due May 25, 1982 and final installment due April 25, 1985

with interest thereon from date at the rate of **22.10** per centum per annum, to be paid:

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of and other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

Austin Township, in Laurel Creek Section of City and State Aforesaid, containing 3.63 acres, more or less and being a portion of larger tract of land conveyed to G.G.C. Franklin by J.A. McDavid by deed dated 2/16/06 and recorded in Book RRR at page 163. The lot specifically begins on an iron pin in the center of the Conestee Road at corner of lots formerly conveyed to O.C. Ferguson, and running thence S. 64 W. 498 feet to an iron pin on the Ferguson line' thence S. 2 1/2 E. 292.38 feet to an iron pin; thence N. 80 1/2 E. 436.3 feet to an iron pin in the center of Coenstee Road thence along the center of the said road N. 2 1/2 W. 419.1 feet to an iron pin, corner of ther Ferguson or Formerly property the point of being the same property in School district 299 being shown on the County Block Book M 11.2-1-3.

The above described property is the same conveyed to Newton Bell by deed of Vantross Franklin at al, dated 10/23/47, recorded in RMC Office for Greenville County,, S.C. in deed Volume 341 at page 83

The grantors and the grantee herein are the sole surviving heirs at law of Newton Bell who died intestate on 3/4/60, and this deed is made by the grantors to their sister, the grantee herein as a part of the division of the property of their Father.

The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
