

Beginning at an iron pin on the Eastern side of Parkins Mill Road at the joint front corner of Lots Nos 16 and 17 and running thence with the line of Lot No. 17, S 88-03 E 168.7 feet to an iron pin in the line of Lot No. 15; thence with the line of Lot No. 15, S 1-31 W 150.0 feet to an iron pin on the Northern side of Faversham Circle at the joint corner of Lots Nos. 15 and 16; thence with the Northern side of Faversham Circle, the following courses and distances: N 87-59 W 145.0 feet to an iron pin; thence N 42-56 W 35.32 feet to an iron pin on the Eastern side of Parkins Mill Road; thence with the Eastern side of Parkins Mill Road; thence with the Eastern side of Parkins Mill Road, N 2-06 E 125.0 feet to an iron pin, the point of beginning.

This being the same property conveyed to mortgagor herein by deed of Williams Street Development Corp. dated June 1, 1982 and recorded simultaneously herewith.
