THIS ADJUSTABLE RATE RIDER is made this 9th day of April , 1981, and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust, or Deed to Secure Debt (the "Security Instrument") of the same date given by the undersigned (the "Borrower") to secure Borrower's Adjustable Rate Note to First Federal Savings and Loan Association of South (the "Lender") of the same date (the "Note") and covering the property described in the Security Instrument and located at:

107 Fairhaven Drive, Taylors, S.C. 29687

(Property Address)

The Note contains provisions allowing for changes in the interest rate every year subject to the limits stated in the Note. If the interest rate increases, the Borrower's monthly payments will be higher. If the interest rate decreases, the Borrower's monthly payments will be lower.

ADDITIONAL COVENANTS. In addition to the covenants and agreements made in the Security Instrument, Borrower and Lender further covenant and agree as follows:

A. INTEREST RATE AND MONTHLY PAYMENT CHANGES

The Note provides for an initial interest rate of 9.875. Section 4 of the Note provides for changes in the interest rate and the monthly payments, as follows:

"4. INTEREST RATE AND MONTHLY PAYMENT CHANGES

(A) Change Dates

The Interest rate 1 will pay may change on the first day of May , 1985, and on that day every 12th month thereafter. Each date on which my Interest rate could change is called a "Change Date."

(B) The Index

Beginning with the first Change Date, my interest rate will be based on an Index. The "Index" is the weekly average yield on United States Treasury securities adjusted to a constant maturity of 1 year, as made available by the Federal Reserve Board. The most recent index figure available as of the date 45 days before each Change Date is called the "Current Index."

If the index is no longer available, the Note Holder will choose a new index which is based upon comparable information. The Note Holder will give me notice of this choice.

The first index figure for this note is 10.35%. It is called the "Original Index."

The Original Index plus a margin of 2.500% (after rounding the result up to the nearest 1/8 of 1%) is called the "Adjustment Base Rate."

(C) Calculation of Changes

Before each change date, the Note Holder will calculate my new Interst rate by calculating the difference,

The rate of interest I am required to pay shall never be increased or decreased on any single Change Date by more than one and three-quarters percentage points (1.75%) from the rate of interest I have been paying for the preceding twelve months.

(E) Effective Date of Changes
