"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE.

ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as Lot No. 106 as shown on plat of PARKER HEIGHTS Subdivision recorded in the RMC Office for Greenville County in Plat Book P at Page 43-B and having such metes and bounds as shown thereon, reference to said plat being made for a more complete description. Said lot fronts 50 feet on West Marion Road, runs back to a uniform depth of 150 feet, and is 50 feet across the rear.

THIS is the same property as that conveyed to the Mortgagors herein by deed of Billy C. Hill recorded in the RMC Office for Greenville County of even date herewith.

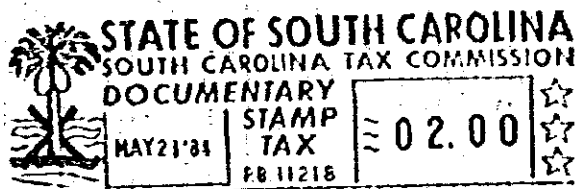
