

In the event of any default in any of the covenants or agreements contained in the building loan agreement above referred to, or in this Mortgage, WACHOVIA MORTGAGE COMPANY, may, at its option, defer foreclosure proceedings and may take action under and invoke the rights and remedies provided in said building loan agreement and in this Mortgage.
