1. BORROWER'S PROMISE TO PAY

In return for a loan that I have received, I promise to pay U.S. \$96,800.00 (this amount is called "principal"), plus interest, to the order of the Lender. The Lender is ROOSEVELT FEDERAL SAVINGS AND LOAN ASSOCIATION. I understand that the Lender may transfer this Note. The Lender or anyone who takes this Note by transfer and who is entitled to receive payments under this Note is called the "Note Holder."

2. INTEREST

Interest will be charged on unpaid principal until the full amount of principal has been paid. I will pay interest at a yearly rate of 10.00~%. The interest rate I will pay will change in accordance with Section 4 of this Note.

The interest rate required by this Section 2 and Section 4 of this Note is the rate I will pay both before and after any default described in Section 7(B) of this Note.

3. PAYMENTS

(A) Time and Place of Payments

I will pay principal and interest by making payments every month.

I will make my monthly payments on the 6TH day of each month beginning on JULY 6, 19 84. I will make these payments every month until I have paid all of the principal and interest and any other charges described below that I may owe under this Note. My monthly payments will be applied to interest before principal. If, on JUNE 6, 2014, I still owe amounts under this Note, I will pay those amounts in full on that date, which is called the "maturity date."

(B) Amount of my Initial Monthly Payments

(C) Monthly Payment Changes

Changes in my monthly payment will reflect changes in the interest rate that I must pay. The Note Holder will determine my new interest rate and the changed amount of my monthly payment in accordance with Section 4 of this Note.

4. INTEREST RATE AND MONTHLY PAYMENT CHANGES

(A) Change Dates

The interest rate I will pay may change on the 6TH day of DECEMBER, 19 84, and on that day every 6th month thereafter. Each date on which my interest rate could change is called an "Interest Change Date".

The amount of my monthly payments may change on the $\frac{6\text{TH}}{0}$ day of $\frac{30\text{LY}}{0}$, $\frac{19}{0}$, $\frac{85}{0}$, and on that day every 12th month thereafter. Each date on which my payment amount could change is called a "Payment Change Date."
