1. To pay, prior to becoming delinquent, all taxes, assessments, dues and charges of every kind imposed or levied upon the real property described below; and

2. Without the prior written consent of Association, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein; or any leases, rents or funds held under escrow agreement relating to said premises; and

3. The property referred to by this agreement is described as follows:

ALL that piece, parcel and lot of land, situate on Tanyard Road, near the intersection of SC Highway 253, and adjacent to that land of Flvis W, and Joyce A. Wood, and being shown on survey and plat prepared by Clifford C. Jones, dated May 15, 1978, entitled "Property of the Haygood Estate", and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on Tanyard Road, the northwest front corner of property of Grantee and Joyce A. Wood, and runs along common line of said property, S. 50-04 E. 316.9 feet to an iron pin; thence as rear line, S. 27-00 W. 100 feet to iron pin; thence along line of other Hagood Estate property, N. 40-25 W. 327.9 feet to iron pin on Tanyard Road; thence along said

road, N. 20-43 E. 45 feet to iron pin, the BEGINNING corner.

That if default be made in the performance of any of the terms hereof, or if default be made in any payment of principal or interest, on any notes hereof or hereafter signed by the undersigned agrees and does hereby assign the rents and profits arising or to arise from said premises to the Association and agrees that any judge of jurisdiction may, at chambers or otherwise, appoint a receiver of the described premises, with full authority to take possession thereof and collect the rents and profits and hold the same subject to the further order of said court.

4. That if default be made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to Association when due, Association, at its election may declare the entire remaining unpaid principal and interest of any obligation or indebtedness then remaining unpaid to Association to be due and payable forthwith.

5. That Association may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Association, in its discretion, may elect.

6. Upon payment of all indebtedness of the undersigned to Association this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benefit of Association and its successors and assigns. The affidavit of any officer or department manager of Association showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby actionized to rely thereon.
