acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said
L.A. Stone, all that piece, parcel or lot of land situate, lying and being in the County and
State aforesaid, having the following metes and bounds:

Beginning at an iron pin on Hubert St. and runs; thence with Wheeler lot 180 ft. to J.M.-
Miller's line; thence along the line of J.M. Miller and O.P. Smith 289 ft. to C. Littlefield's
corner; thence along C. Littlefield's line 180 ft. to said Hubert St.; thence along said
Street 289 ft. to beginning corner.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-
wise incident or appertaining.
