acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said  
J.E. Washington, Paster and H.S. Hawkins, George Johnson and Thos. J. Davis, Trustees of Reedy River  
Baptist Church, All that certain lot or parcel of land situate in town of Mauldin, County and State  
aforesaid, containing two acres, more or less, and having the following metes and bounds to wit:
