Orr and hath the following metes and bounds to wit: Beginning at an iron pin in Langston Creek, John L. Drake's corner, running S.89- $\frac{1}{2}$ E. 6.96 to an iron pin at Furman Road; thence N. 8- $\frac{1}{2}$ E. 1.01 to iron pin on said road; thence N. 87 W. 7.08 to iron pin in Langston Creek; thence down said Creek to beginning, containing (1) one acre, more or less.
