S.S. Knight of Fountain-Inn (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said S.S. Knight a lot in the Town of Fountain Inn, known as Lot (No. 102) One hundred and two by the plan of Survey made by John R. Hellams of the Town of Fountain Inn, and bounded by a Street called Jones Street, a lot (NO. 103) belonging to Young R. Scruggs, Lot No. 101 on which the Parsonage of the M.E. Church stands and lands belonging to Jas. A. Cannon, formerly by Cannon & West; and consisting of three-fourths (3/4) of an acre, it being the same house and lot I purchased of Wm. J. West late deceased.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.
