

W.C. Cleveland Deed TO W.M. Burnett

KNOW ALL MEN BY THESE PRESENTS, That: I, W.C. Cleveland of the City and County of Greenville, and in the State aforesaid in consideration of the sum of Seventeen hundred Dollars, to me in hand paid at and before the sealing of these presents by W.M. Burnett

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said W.M. Burnett All that piece, parcel or lot of land situate, lying and being on the North side of Carrier Street in Ward two of the City of Greenville, County and State aforesaid, being known as Lot number 31, on the subdivision of the W.C. Cleveland property, plat of which is recorded in the Cleveland & Williams Plat Book in the office of the Register of Mesne Conveyance for Greenville County and having the following metes and bounds to wit: Beginning at a stake on the North side of Carrier Street corner of lot number 32; thence with line of said lot N. 26-59 E. 172.5 feet to stake on alley; thence with line of said alley S. 63-01 E. 70 feet to stake; thence with line of lot number 30, S. 26-59 W. 172.5 feet to stake on Carrier Street; thence with Carrier Street N. 63-01 W. 70 feet to beginning stake.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said W.M. Burnett, and his heirs and assigns, forever.

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and forever defend all and singular the said premises unto the said W.M. Burnett, and his

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
