KNOW ALL MEN BY THESE PRESENTS, That I, Wilburn Lindsay

in the State aforesaid
in consideration of the sum of Five Dollars,
to me in hand paid at and before the sealing of these presents by

Joshua Lindsay

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Joshua Lindsay, A certain piece, or parcel of land lying and being in the County and State aforesaid on branch waters of Greens Creek and in Glassy Mountain Township, having the following metes and bounds:

Beginning on a rock near a Spring on the road; thence N.E. to a rock called the Cedar Rock; thence S.E. to a Blazed Chestnut-oak; thence to a chestnut corner on the same course; thence S.E. to a rock; thence S.E. to a Pine; thence S.E. to a rock on the Stephen Center line; thence with Stephen Center line to a red-oak; thence to a maple on James Center; thence nearly West to a chestnut oak; thence with mountain road to G.D. Lindsay line; thence with C.D. Lindsay line to a pine; thence with Mountain Road to the beginning corner, containing sixty-five acres, more or less.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Joshua Lindsey, his heirs and assigns, forever.

AND I do hereby bind myself, my heirs, executors and administrators, to warrant and forever defend all and singular the said premises unto the said Joshua Lindsey, his

heirs and assigns, against myself and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
