KNOW ALL MEN BY THESE PRESENTS, That I, J. W. Griffin of Oglethorpe County, in the State of Georgia, in the State aforesaid

for and in consideration of the sum of One hundred and fifty Dollars, to me in hand paid at and before the sealing of these presents by

H. H. Griffin of the County of Greenville and State of South Carolina. (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said H. H. Griffin all that piece, parcel and tract of land situate, lying and being in the State of South Carolina and Greenville County and Dunklin Township, containing nine and three-fourths acres more or less, and bounded now or formerly by lands of Jesse L. French, Georgia Ann Johnson, Harriett C. Chapman and others and being the same tract of land conveyed to Violet Sullivan by Worth Seaborn, Georgia Ann Johnson, Willis Seaborn and Harriett Chapman by deed bearing date the 30th, day of August 1897 and recorded in the office of the Register of Mesne Conveyance for said County of Greenville in Book D.D.D. page 173, and being the same tract of land conveyed to me by the said Violet Sullivan by deed bearing date the 15th, day of October 1899.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.
