

Daisy Todd Wilson Deed TO D.P. Cox

KNOW ALL MEN BY THESE PRESENTS, That I, Daisy Todd Wilson, of Greenville County

in consideration of the sum of Seventy-five Dollars, to me in hand paid at and before the sealing of these presents by

D.P. Cox, of the State and County aforesaid (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

D.P. Cox, all of that certain triangular lot of land, situated in the State and County aforesaid in the Town of Simpsonville, on the West side of Main Street, adjoining lands of Mrs. Daisy Todd Wilson, and D.P. Cox and having the following metes and bounds:

Beginning at iron pin on Mrs. Wilsons line at the edge of Main Street and thence N. 86-3/4 W. three hundred and sixty-nine feet to iron pin; thence S. 15-3/8 E. ninety six and one-half feet to iron pin; thence N. 78 E. three hundred and fifty feet to the beginning.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said D.P. Cox, and his heirs and assigns, forever.

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and forever defend all and singular the said premises unto the said D.P. Cox, and his

heirs and assigns, against myself and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
