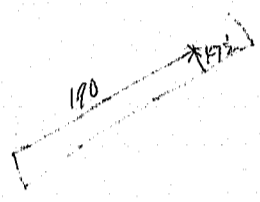
KNOW ALL MEN BY THESE PRESENTS, That I, Claudius I. Campbell, of Greenville County in the State aforesaid

for and in consideration of the sum of Six hundred and fifty (\$650.) Dollars, to me in hand paid at and before the sealing of these presents by

Ella J. Reece (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Ella J. Reece all that piece, parcel or lot of land in Greenville County, State of South-

Carolina:

Beginning at a stake on David Street which runs from Goldsmith Street to Southern Railway track just beyond incorporate limits of the City of Greenville, running; thence S. 48° 30 W. 190 feet to a stake on the Alley, S. 41° 30 E. 47-1/2 feet to a stake on J.N. Campbells line; thence with Campbells line N. 48° 30 E. to stake on David Street; thence with said David Street N. 41° 30 W. 47-1/2 feet to beginning corner the same being part of Lot No. 73 of parcel No. 10 of the Hammett Land, according to plat made by Wm. F. Lee. This being same lot conveyed to me by J.N. Campbell, see Book Z.Z.Z. page 71.



TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Ella J. Reece, her heirs and assigns, forever.

AND I do hereby bind myself, my heirs, executors and administrators, to warrant and forever defend all and singular the said premises unto the said Ella J. Reece, --

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
