in the State aforesaid

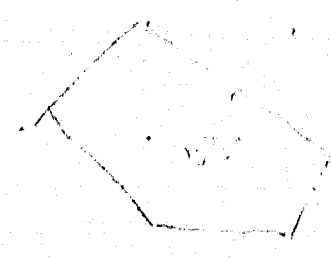
for and in consideration of the sum of One hundred and five Dollars,

W.P. Gresham of Simpsonville, Greenville County (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

W.P. Gresham, a certain piece, parcel or tract of land situate, lying and being in Austin Township, Greenville County and State aforesaid on Horse Pen Creek, branch waters of Enoree River:

Beginning at R.O. 3X; thence N. 15 E. 5.22 to a stone 3X; thence N. 62 W. 14.85 to a stone 3X; thence S. 66 W. 7.59 to a stone, Greshams corner 3X; thence S. 59 E. 9.62 to a Pine 3X; thence S. 76 1/2 E. 9.89 to the beginning R.O., containing 10 1/2 acres, be the same more or less.
