KNOW ALL MEN BY THESE PRESENTS, That I, J.W. Fowler, of Fountain Inn

in the State aforesaid
for and in consideration of the sum of One Dollars,
to me in hand paid at and before the sealing of these presents by

The Town of Fountain Inn (the receipt whereof is hereby
acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Town of Fountain Inn, all that lot or parcel of land lying, being and situate in the Town
of Fountain Inn, County and State aforesaid:

Commencing at corner of L.P. Armstrong Stable, running with Armstrongs line 20 feet;
thence Southeast about 68 feet or across my lot to D.M. Garretts line; thence with D.M.-
Garretts line 20 feet to an iron pin near Gard House; thence Northwest about 68 feet to
beginning corner.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-
wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said
Town of Fountain Inn, and his heirs and assigns, forever.

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and
forever defend all and singular the said premises unto the said Town of Fountain Inn, and his

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to
claim the same, or any part thereof.
