KNOW ALL MEN BY THESE PRESENTS, That I, J. E. Roe of Greenville County

in the State aforesaid

in consideration of the sum of Seventeen hundred and fifty Dollars

to me in hand paid at and before the sealing of these presents by Annie E. Roe

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Annie E. Roe all that certain piece, parcel or lot of land situate and being in the Town of Greer, County and State aforesaid, and designated as lot # 4 on Block # 1 on a plat of land recorded in R.M.C. office in and for said County in Book A page 299 being the same lot of land conveyed to me by Anna E. Green in deed bearing date of March 23rd, 1909 and recorded in R.M.C. office in Book E page 121 in Greenville.

Also all that other piece parcel or lot of land situate lying and being in the Town of Greer State and County aforesaid, Beginning on H. S. Stokes and running thence with B. W. Burnett's and J. E. Roe's line sixty five (65) feet; thence in direct line sixty four (64) feet to line of L. J. Green or lot No. 9 of Block # 1; thence with L. J. Green's line or lot # 9 Block # 1 sixty five feet to H. S. Stokes line; thence with H. S. Stokes's line sixty four (64) feet to the beginning corner being part of lot No. 8 block No. 1 as shown on above mentioned plat.


