acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

J.W. Cannada, all that piece, parcel or tract of land situate, lying and being in the State and County aforesaid on the left bank of Childress Beaverdam Creek, waters of South Tyger River, in O'Neal Township and has the following metes and bounds, to-wit:
