KNOW ALL MEN BY THESE PRESENTS, That I, Loula M. Briggs of the County of Greenville and

in consideration of the sum of Four thousand five hundred (\$4500.00) Dollars to me in hand paid at and before the sealing of these presents by

Robert Roper Scales

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Robert Roper Scales, All that piece, parcel and lot of land situate, lying and being in the State and County aforesaid, in the first Ward of the City of Greenville, and on the North East side of Pinckney Street:

Beginning at the corner of Lot No. 17, now owned by Paul Houston and running N. $39\frac{1}{2}$ E. with said Houston's line 296 feet to a stake at Carlisle's line; thence N. $33\frac{1}{2}$ W. with said Carlisle's line 22 $\frac{1}{4}$ feet to a stake at Miss Powell's line; thence S. $55\frac{1}{2}$ W. with said Powell's line 153 feet to a stone, corner of said Powell's lot and lot No. 21; thence S. $39\frac{1}{2}$ W. with line of Lot No. 21- 147 feet to Pinckney Street; thence S. $50\frac{1}{2}$ E. with said Street 68 feet to the beginning corner, being lot designated as No. 19, in the division of the Home Place of W.P. McBee, deceased, shown by plat made May 16th, 1902 by J.N. Southern, D.S. and recorded in Plat Book A. page 83. The said lot having been set off and conveyed to me by F.B. McBee, V.E. McBee and M.P.
