Bramlett Elizabeth Bramlett (Decd.) and in the further consideration of the sum of Five Dollars in consideration of the sum of An equal partition and division of the Estate of Dollars to us in hand paid at and before the sealing of these presents by W.C. Bramlett (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

W.C. Bramlett, all that piece, parcel or tract of land situate, lying and being in the State and County aforesaid on Waters of Wiers Creek, waters of North Saluda River and in Saluda Township and has the following metes and bounds, to wit:

Southern's line; thence N. 66-1/2 E. 18.50 ch. to a stone; thence S. 32 W. 49.40 ch. to a stone on Hattie Speegles line; thence S. 49-1/2 E. 9.95 ch. to a stone; thence S. 65-1/2 E. 4.00 ch. to a stone; thence S. 81 E. 14.00 ch. to stake in road; thence N. 33 W. 2.00 ch. to a stone; thence N. 47-1/2 E. 7.75 ch. to a stone on branch; thence N. 18-3/4 E. 10.30 ch to a stone; thence N. 25-1/4 E. 25.00 ch. to the beginning corner, containing one (107) hundred and seven acres, more or less, adjoining lands of W.D.
