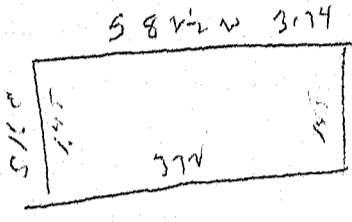

J.E. Jones (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

J.E. Jones, all that lot or parcel of land lying, being and situate in the Town of Simpsonville, County and State aforesaid, containing one half acre, more or less and hath the following metes and bounds, to wit: bounded by Lillie Moore, Stage Road and others, Commencing at a stone on road, running; thence S. 82-1/2 W. 3.74 to a stone 3X; thence S. 16-1/2 E. 1.45 to a stone 3X; thence N. 82-1/2 E. 3.72 to a stone 3X; thence N. 15 W. 1.45 to beginning corner, the same being a lot No. 4, of a survey made this day by J.A. Adams.
