KNOW ALL MEN BY THESE PRESENTS, That I, Samuel Caldwell of Greenville

in consideration of the sum of Seven hundred Dollars

to me in hand paid at and before the sealing of these presents by

D.T. Coker of Simpsonville, S.C. (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

D.T. Coker, all my undivided interest in all that piece, parcel or tract of land situate, lying and being County & State aforesaid on branch waters of Horse Pen Creek, waters of Enoree River containing forty and one-fourth (40- $\frac{1}{4}$) acres more or less:

Beginning at a stone 3X0M; thence S. $69\frac{1}{2}$ E. 18.97 ch. to a stake P.O. gone 3X; thence S. 53 W. 40.75 ch. to a stone 3X; thence N. $42\frac{1}{2}$ W. 6.75 ch. to a stone 3X; thence N. $43\frac{1}{2}$ E. 19.50 ch. to a poplar on branch 3X; thence S. 59 E. .35 ch. down said branch to center of road; thence down said road 13.65 to the beginning corner, bounded by lands Alex Abercrombie, J.W.H.
