Mims Cox, of Greenville County, in the State aforesaid in consideration of the sum of **Fifty-five** Dollars to us in hand paid at and before the sealing of these presents by**Byron Cox,** (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said**Byron Cox, his heirs and assigns, all that certain parcel or tract of land situate in the County and State aforesaid, bounded by lands of Byron Cox and W.M. Cox and H.M. Moore, containing four and eight-tenths acres, more or less, being a part of the James R. Cox Estate and hath the following metes and bounds:**

Beginning at a stone, corner of Byron Cox's and W. Mims Cox's place and running S. 82 W. 10.90 to a stone, corner of W. Mims Cox's, H.T. Cox's, R.R. Rice's, H.M. Moore's Places; thence S. 42-1/2 E. 10.83 to a stone; thence N. 19-3/4 E. 10.00 to beginning corner.
