Townes, her heirs and assigns forever all that certain piece, parcel or tract of land situate, lying and being in South Carolina in Greenville County in Dunklin Township containing sixty-three acres, more or less on West bank of Horse Creek on stone 3X; thence S. 76- $\frac{1}{2}$ W. 4.00 to stone 3XNM; thence S. 33- $\frac{1}{2}$ W. 3.15 to a stone 3XNM; thence S. 72- $\frac{1}{2}$ W. 3.90 to stone 3XNM; thence S. 62- $\frac{1}{2}$ W. 5.00 to stone 3XNM; thence N. 26- $\frac{1}{2}$ E. 19.00 to white oak stone 3XOM; thence N. 54 E. 4.70 to White oak NM; thence S. 86 E. 6.00 to stone 3XNM; thence -- 86 E. 18.26 to Creek; thence down Creek about 20 chains to the beginning corner, being same tract of land conveyed to me by James B.
