KNOW ALL MEN BY THESE PRESENTS, That I, Robert Foster

in the State aforesaid

in consideration of the sum of Five hundred Dollars to me in hand paid at and before the sealing of these presents by

L.H. Littlefield (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

L.H. Littlefield, All that piece, parcel or lot of land situate, lying and being in the County and State aforesaid, having the following metes and bounds:

Beginning on an un-named Street at Jane Jenkin's corner and runs; thence with this Street 63 feet to S.H. Foster's corner; thence with his line 152 ft. to Mose McKissick's line; thence with his line 43 ft. to Jenkin's line; thence with Jenkin's line 152 ft. to beginning corner, being the interest of Robert Foster in the tract of land conveyed to him and S.H. Foster by L. Jackson-Green in deed bearing date March 1st, 1907.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said premises before mentioned unto the said L.H. Littlefield, his heirs and assigns forever.

AND I do hereby bind myself, my heirs, executors and administrators, to warrant and forever defend all and singular the said premises unto the said L.H. Littlefield, his

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
