

A. T. Fortner DEED TO M. H. Gilbert

KNOW ALL MEN BY THESE PRESENTS, That I, A. T. Fortner

in the State aforesaid in consideration of the sum of Five hundred and no/100 (\$500.00) Dollars to me in hand paid at and before the sealing of these presents by

M. H. Gilbert (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

M. H. Gilbert, all that piece, parcel or lot of land situate, lying and being in the State and County aforesaid on the North-west side of the Paris Mountain Road, three and one-half miles from Greenville Court House, containing three (3) acres, more or less, and having such marks and bounds as are herein set forth, to-wit:

Beginning on an iron pin in said road; thence along said road N. 80-3/4 W. 5.51 chains to an iron pin at bend of said road; thence N. 42-1/3 E. 4 chains to an iron pin at bend in said road; thence N. 11-2/3 W. 3.26 chains to an iron pin at crossing of old road; thence leaving lands of Mrs. Fannie E. Harris and lands of Jerry E. Smith along old road S. 56-2/3 W. 10.88 chains to an iron pin in said road; thence along line of Marion P. Hall S. 56-2/3 E. 1.93 chains to the beginning corner.
