Shockley all that certain parcel or lot of land situate in the State aforesaid, County of Greenville and in the Town of Greer on the North side of Hubert Street, having the following metes and bounds to wit: Beginning at an iron pin on Hubert St. and runs thence nearly north with Wheeler line one hundred and eighty (180) feet to Keating line; thence with the Keating line one hundred and sixteen (116) feet; thence in a direction parallel with said Wheeler line to Hubert St.; thence with said Street one hundred and sixteen (116) feet to the beginning corner, being a part of the lot conveyed to me by J. 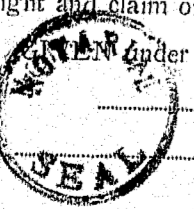
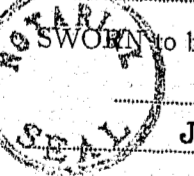
