Louise W. Speegle, All my undivided two fifths interest in and to all that certain piece,
parcel and tract of land situated in South Carolina, in Greenville County, in Greenville
Township, bounded by lands of H.K. Townes, the Air Line Railway Company, Saluda River, and
G.A. Buitt, being the home place of the late Mrs. B. Fannie Whitmire, being part of the tract
conveyed by W.H. Irvine to B. Fannie Whitmire by deed dated Nov. 20th, 1894, and recorded in
R.M.C. Office for said Greenville County in Deed Book B.B.B. page 73. My interest having been

and West of Hampton Avenue, beginning at an iron pin on line of property of Southern Railway
Company, said beginning corner being at the corner of lot No. 10, and running thence with the
