Ferguson (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

James M. Ferguson, all that certain piece, parcel or lot of land situate, lying and being in the County and State aforesaid, in Ward two of the City of Greenville, on the North side of Earl Street and fronting thereon sixty-three (63) feet and ten (10) inches with a depth of Two hundred and fifty (250) feet, more or less, and being lot number one of section "F" of a plat of the property of the Stone Land Company made by J.E. Sirrine May 21st, 1909, recorded in R.M.C. office for Greenville County, State aforesaid, in Plat Book "A" PP. 337-342. This being one of the lots conveyed to me by said Stone Land Company and recorded in R.M.C. office for State and County aforesaid in Book XXX, page 73. Said property being conveyed to me June 25th, A.D. 1909.

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

J.C. Jarrard, his heirs and assigns all those certain lots of land situate near the City of Greenville in the County of Greenville, South Carolina, being a part of what is known as City View Land Company, and as is recorded in Plat Book A. pages 460 and 461, to wit:

Lots Nos. 9, 10, 11, 12 and 13, all fronting on the West side of Y.M.C.A. Street, each having a frontage thereon of fifty feet and each runs back in parallel lines one hundred and fifty feet to a ten foot alley; also Lots 45, 46, 47, 48, 49 and 50, the last numbered lot being on corner of Henderson and Summitt Streets and each of said lots being on the East side of said Henderson Street and each fronting fifty feet and run back in parallel lines one hundred and fifty feet to a ten foot alley, also lots 67, 68, 69, and 70 on the West side of said Henderson Street each fronting it fifty feet and each run back in parallel lines one hundred and fifty feet to a ten foot alley.
