to me in hand paid and before the sealing of these presents by Thos. E. Lister of the Same State and County
have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said Thos E. Lister all of our interest in all that certain piece or parcel of land situated, lying and being in the aforesaid State and County on both sides Middle Tyger River, join lands of A.J. Farmer, Ohara Barton & others, the same being the western portion of the tract of land bequeathed to E.B. Baronette and M.R. Lister by Polly Henson in will bearing date the 18, day of Aug. 1856 and nearly all the tract conveyed to E.B. Baronette and M.R. Lister by John Herison and bearing the following corners and distances, Viz:
