 to me in hand paid at and before the sealing of these presents by D. T. Kinard (the receipt whereof

is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said D. T. Kinard a certain piece or parcel of land situate lying and being in the State and County aforesaid Cleveland Township on waters of Middle-Sabuda River with the following metes and bounds to wit: Beginning at stone in Jaysons line thence 40° 11.16' to an iron pin Jaysons corner thence South 50° 46.59' to an iron pin on south side of Head Foremost Creek thence South 75° 22.96' corner at mouth of ditch thence 42° 8' 4.76" to head of ditch N. 25° 23.84' to old chimney place on ridge thence N. 57° 02' to pocket gum on branch thence N. 27° 2.76' to black gum; thence N. 42° 11.14' to Beech tree; thence N. 31° 14.25' to white oak thence N. 33° 11.14' to poplar; thence due W to the beginning containing 7.62 acres more or less adjoining lands of C.
