- if they so desire. Now, should the said LONG BLUE GRANITE COMPANY fail or refuse to pay the ground rental to the said Mary C. Harris, or her assigns, as per contract of lease, dated July 29th, 1911, then the said BAPTIST COURTER COMPANY shall cease to pay all rental as per this contract to the LONG BLUE GRANITE COMPANY, and shall pay over the same to the said Mary C. Harris or her assigns; and that the said LONG BLUE GRANITE COMPANY shall then and there shall relinquish all claims they may have, or have had, to the said premises. The failure of the LONG BLUE GRANITE COMPANY to comply with their lease contract with the said Mrs. Mary C. Harris, the Lessor, shall in no way affect the rights of the said Lessee the BAPTIST COURTER COMPANY.
