Know all men by these presents that I M.A. Hunter of Laurens District of the State aforesaid that for and in consideration to me in hand paid of the sum of Fourteen hundred and eighty-two Dollars by John J. White of the State and District aforesaid have bargained and sold and by these presents do grant, sell, release and relinquish unto the said John J. White all that tract or parcel of land lying and being in Greenville District, owned until March 20th, 1856 by John Baldwin from whom I purchased said land and State aforesaid, being several tracts bought by said Baldwin, consisting as follows:- Viz- One tract from Wm. Johnson, containing one hundred and ninety two acres, having such courses, bounds and buttings as represented by said deed dated 13th, of March 1833, less all that lies to the right of the road leading from Simeon Westmoreland to S.K. White's being about ten acres.- One other tract, containing sixty one acres as represented by deed of Jeremiah Gilbert to said Baldwin, dated 28th, Oct. 1843, the courses, distances and boundaries are specified in said deed, also one other tract, containing four Acres and one-half, deeded to said Baldwin by Elisha League 18th, June 1839, courses, distances also represented in said deed- All of which lands are on a branch of Gilders Creek and a branch of Enoree River, bounded now by lands at present owned by S.K. White, W.D. Hunter, Capt. Jones Templeton and others, all-together containing Two hundred and forty seven acres, more or less.
