N. 22 ft. E. 16 ft. S. 22 ft. W. 16 ft. and is the lot on which many of the McClanahan family are buried, for the right of burial and cemetery purposes, and to be used exclusively for the right and purpose aforesaid, and subject to the conditions of the Charter of said grantor, and

It is understood and agreed, however that the City Council of Greenville does not warrant the title of the said lot to the said Mrs. Annette Feaster Palm, and that if the question should arise as to who the owner of said lot is in the future kinam, that question is to be settled between her and whosever shall claim the same: It being the intention of the City Council to hereby convey only such right as it has in the premises.
