Dillard, decessed, for and in consideration of the sum of FIVE THOUSAND SEVEN HUNDRED AND NINETY (\$5,790.00) DOLLARS to me in hand paid by the said Sunie Elmore, ( the receipt whereof is hereby acknowledged,) and in pursuance of the power vested in me under and by said Will, have granted, bargained, solf and conveyed, and by these Presents do grant, bargain, sell and convey unto the said Sunie Elmore, that certain tract of land situate in the County and State aforesaid, containing ninety six and one half (96-2) acres, more or less, being a part of the Home Place of the said M.G. Dillard, deceased, designated on plat made by W.D.
