I, J. W. Gray, Master in and for the County aforesaid, SEND GREETING:

WHEREAS, John S. Walker, et al,

on or about the 22nd day of January in the year of our Lord nineteen hundred and fourteen exhibited their complaint in the Court of Common Pleas, for the County aforesaid, against

Asa A. Green, as Executor of the last Will and Testament of W. Howell, deceased, et al,

demanding judgment in relation to the real estate hereinafter mentioned and described; and the cause being at issue, came on to be heard on the 20th day of March 1914, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be sold by J. W. Gray Master in and for the County aforesaid, on the terms and for the purposes mentioned in the said decree as by reference thereto on file in said Court will appear; and the Master, after having duly advertised the said real estate for sale by public outcry on the 6th day of April in the year of our Lord nineteen hundred and fourteen did then openly and publicly, according to the custom of auction, sell and dispose of the same unto R. for the sum of Seven Hundred and Sixty Dollars, being at that price the highest bidder therefor. NOW, THEREFORE, Know all men by these Presents, that I, J. W. Gray Master in and for County of Greenville, aforesaid, in consideration of the sum of Seven Hundred and Sixty Dollars, to me paid by the said R. J. Rowley and S. F. Hunt,

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said R. J. Rowley and S. F. Hunt; All those two certain parcels or lots of land situated in the County and State aforesaid, known as lots nos. 9 and 10, in the plot of survey of the lands of which Martha J. Howell, died, seized and possessed, made by W. A. Adams, Surveyor, on the 10th day of March, 1914, having the following metes and bounds to-wit: Lot no. 9, beginning at a stake on the Spartanburg Road and running thence N. 42 E. 95 feet to a stake, thence N. 9 1/2 W. 190 feet to a stake, corner of Lot no. 10; thence S. 55 1/2 W. 222 feet to a stake; thence S. 48 E. 202.4 feet to the beginning corner. Lot no. 10, beginning at a stake on Street and running thence N. 67 E. 84.5 feet to a stake, corner of Lot no. 9; thence N. 55 1/2 E. 222 feet to a stake, corner of Lot no. 9; thence N. 9 1/2 W. 86 1/2 feet to a stake, corner of Lot no. 11; thence S. 67 1/2 W. 290 feet to a stake, corner of Lot no. 11 and Street; thence S. 9 E. 112 feet to the beginning corner.
