TO ALL WHOM THESE PRESENTS SHALL COME:

I, J.W. Gray, Master in and for the County aforesaid, SEND GREETING:

WHEREAS, Bessie Edens, and others

on or about the 21st, day of April in the year of our Lord nineteen hundred and eleven exhibited their complaint in the Court of Common Pleas, for the County aforesaid, against Nannie Lou Arnold, and others

demanding that the real estate described in the complaint be partitioned among the parties interested therein; and the cause being at issue, came on to be heard on the 22nd, day of June 1911, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by J.W. Gray

Ansel F. Arnold Master in and for the County aforesaid, to for the purposes mentioned in the said

decree, as by reference thereto on file in said Court, will appear; (See Judgment Roll No. --).

NOW, THEREFORE, Know all men by these Presents, that I, J.W. Gray Master in and for the County of Greenville aforesaid, by virtue of the aforesaid decree, HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said

Ansel F. Arnold, all those certain lots or parcels of land situate in Greenville Township County and State aforesaid, about three and one-half miles West of Greenville Court House near the Southern Railway, known as Lots "B-1" & "B-2" in plat of the lands of the Estate of Ansel Arnold, deceased, made pursuant to order of the Court, by F.G. Rogers, surveyor August 2, 1911 and having the following metes and bounds, to wit:

"B-1"- Beginning at a stake on the right of way of the G.S. & A. Railway, corner of lot "A-2" and running thence with line of lot "A-2", N. 81 W. 130 feet to stake; thence with line of lot "A-1", N. 13-1/4 W. 325 feet to stake; thence with line of lot "C", N. 76-3/4 E. 230 feet to stake on right-of-way of G.S. & A. Railway; thence S.W., with said Right-of-way 390 feet to the beginning corner, containing one and sixty-three hundredths (1.63) acres more or less.

"B-2"- Beginning at a stake on right of way of G.S. & A. Railway and running N.E. with said right-of-way 560 feet to stake; thence S. 13-3/4 E. 600 feet to stake, corner of Lot "F"; thence with line of Lot "F", N. 81 W. 200 feet to the beginning corner, containing seventy-nine one-hundredths (0.79) of an acre, more or less. Plat herein referred to is recorded in office of the R.M.C. for Greenville County in Plat Book "A", pages 512 and 513 reference to which is craved.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining; and all the estate, right, title, claim and interest whatsoever, of the parties to the cause aforesaid, and of each of them in and to the same; and all other persons rightfully claiming from, under, or any of them.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned, unto the said Ansel F. Arnold, his heirs and assigns forever.

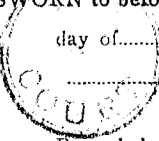
