Inman, Master in and for County of Greenville, aforesaid, in consideration of the sum of Six Hundred (\$600.00) Dollars, to me paid by the said E. M. Simpson

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said E. M. Simpson, the following described real estate:

"All that certain piece, parcel and tract of land situate, lying and being in the County of Greenville, State of South Carolina, and near Bereah Church and containing Thirty-six and one-half (36 1/2) acres, more or less, and being the land which was owned by Georgia Ann Thompson at the time of her death, and being the same land which the said Georgia Ann Thompson received from the partition and division of the estate of her father, Gabriel Thompson."

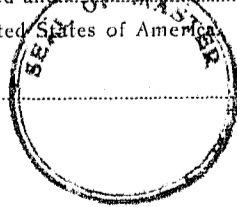
TO HAVE AND TO HOLD, all and singular, the premises before mentioned, unto the said E. M. Simpson, his
