is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

J. H. Allen and R. L. Cruikshank, All those certain lots of land situated in the City of Greenville in said County and State containing about five-eighths ($\frac{5}{8}$) of an acre and on Oscar Street and having located thereon five dwelling houses; bounded on the east by land of J. P. Martin and Jessie J. Pettus, on the north by Kerr Wilson and J. H. Austell, on the west by Lula Hinkle and Henry Orr and on the south by lots of Louis Earle and Oscar Street, also a lot twenty-five feet deep cut off the rear of lots on Bailey Street and adjoining the first described lot known as Lula Hinkle lots and conveyed by A. B. Davis to L. M. Mc Gee and J. G. Wallke; bounded on the east by the first described lot, on north by J. H. Austell, on the West by Garrett and Wallace and on the south by Henry Orr, for a more particular description of these lots see the deeds recorded in the office of the Register of Deeds Conveyance for said Greenville County in deed books 11, 12, page 209, and 13, page 13 wherein said lots are described except a part of thereof which is not included in this deed, being the part which J.
