is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

Dillie J. Butler, All that certain piece, parcel and lot of land situate, lying and  
being in the State of South Carolina in the County of Greenville near the corporate  
limits of the City of Greenville and having the following metes and bounds:  
Beginning on the west side of a proposed street at the point of the inter-  
section of the Woodside line and line of the Buist land and running thence  
with Woodside line S. 42° 45' W. about 475 ft. to the joint corner of Wood-  
side land, Stone land and Buist land, thence with the Stone line S. 80° 15'  
E. — ft. to corner of lot now owned by Ashley A. Butler and 665 ft.  
of Wilton Street; thence with Ashley A. Butler's line N. 8° 00' E. 330 ft. to corner on  
east side of said proposed street being the northeast corner of Ashley A.  
Butler's lot; thence across said proposed street S. 87° W. to point on west side  
of proposed street; thence along the west side of said proposed street N. 8° 00' E. to  
the beginning corner and being a part of the Buist land represented by  
plat recorded in Plat Book "C" page 10 in the office of the Register of  
Mesne Conveyance for said Greenville County. The grantors herein convey
