William A. Williams

KNOW ALL MEN BY THESE PRESENTS, That

I, Joe A. McCullough

in the State aforesaid
Two hours and five hundred in consideration of the sum of
DOLLARS,
to me in hand paid
at and before the sealing of these presents by William A. Williams

(the receipt whereof
is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

William A. Williams, his heirs and assigns, all that piece parcel or lot of land
situate lying and being in the County and State aforesaid about one and
one-half miles west of the Court House and being known as lot no. 81
of the subdivision of lands known as "City View," as plat made by W. A. Adams
Surveyor, having the following metes and bounds to wit: Beginning at a stake
at the corner of O'Neal and Henderson Streets and running thence in a
westwardly direction with O'Neal St. 150 feet to a stake on a ten foot alley;
thence with said alley in a southerly direction fifty (50) feet to a stake
corner of lot no. 82, thence with joint lines of lots no. 81 and 82 in an
easterly direction 150 feet to a stake on Henderson Street; thence with said
alley in a northerly direction fifty (50) feet to a stake at the beginning
corner; also all that piece, parcel or lot of land lying, situate and
being in the state and county aforesaid being known as lot no.
83 of the subdivision of land known as "City View" as shown by
plat of W. A. Adams, Surveyor, and having the following metes and
bounds to wit: Beginning at a stake on Henderson St. 150 feet
from O'Neal Street and running thence with Henderson Street
in a northerly direction 50 feet to a stake, joint corner of lots
no. 82 and 83, thence with joint line of said lots in an easterly
direction 150 feet to a stake on a ten foot alley; thence with said
alley in a southerly direction 50 ft. to a stake joint corner of lots
83 and 84; thence with said joint line in an easterly direction 150
feet to the beginning corner both of these lots being the same lots of land
conveyed to me by G. H. Hicks by deed dated day of April, 1914
