DEED TO W.D. Parrish, et al.

State of South Carolina,

KNOW ALL MEN BY THESE PRESENTS, That Markley Realty Company

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Five dollars and other valuable consideration DOLLARS, to it in hand duly paid at and before the sealing and delivery of these presents by the grantees hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto

W.D. Parrish and T.C. Gower jointly an undivided one-half interest, and unto F.W. Symmes the remaining undivided one-half interest, of, in and to all that piece, parcel or lot of land in Greenville County, State of South Carolina, in the City of Greenville, on the west side of South Main Street, beginning at a drill hole which is 63 feet S. 28-55 W. from the southeast corner of what is known as the new store building as shown on the plat hereinafter referred to, and running thence with Main Street S. 35-18 W. 48.40 feet to an iron pin; thence N. 54-20 W. 94.40 feet to an iron pin on an alley; thence N. 28-55 E. 21 feet to an iron pin, corner of lot No. 9; thence with line of lot No. 9, S. 69-30 E. 100 feet to the beginning corner, and known as lot No. 10 on the plat of Markley Realty Company made by J.E. Serrine, dated March 26th, 1914, and marked N.B. 261.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee hereinabove named, and their heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee hereinabove named, and their heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

In witness whereof the said granting corporation has caused its corporate seal to be hereunto affixed and these presents to be subscribed by its duly authorized officers, J.E. Serrine, President and B.E. Geer, Secretary on this the 1st day of April, in the year of our Lord one thousand nine hundred and fourteen, and in the one hundred and thirty-eighth year of the Sovereignty and Independence of the United States of America.
